i) PA15/05443 – Land adjacent to Chymelyn, Budoock Water – Construction of a detached dwelling & associated works – Revised scheme of PA14/02664 – Budoock Properties Ltd

Considerable discussion took place, with the previous plans 14/02664 also being consulted.

It was proposed by Cllr Bennett and seconded by Cllr Hart and:
