**C.3320 TO RECEIVE A PRESENTATION FROM WALKER DEVELOPMENTS
ON FUTURE PROPOSALS**

Mr Damian Burley and Mr Martin Onsdale gave members an overview of the land that they planned to develop in the future. Some of the land owned by Walker Developments had planning permission; some applications were close to being submitted and for the remainder it was still early days. The first phase at Kernick for one hundred and forty units had planning consent. Phase two was for a sixty bedroomed hotel and restaurant and sixty to seventy houses and some innovation grow space. There was an application imminent for forty one units at College Farm. Walker Development would gift seven eighths of an hectare to be used as a park area. It was a comprehensive development that would deliver housing, employment and leisure.

There were limited formal footpaths on the site and there was a lot of trespassing. They would like to formalise a footpath route through College Valley rather than erect fencing to block entry. They were working to connect into the plans being drawn up by Sustrans.

The design and elevations, infrastructure, country park and associated parking arrangements, entrances to the sites, viability, deliverability,

figures for the industrial units, market for the hotel, site designations, the derelict buildings under the viaduct, affordable housing policy and future consultations were discussed.
