

MINUTES OF THE 844th MEETING OF BUDOCK PARISH COUNCIL, HELD AT BUDOCK VILLAGE HALL, ON MONDAY 25TH JULY 2011

C3137 TO ACCEPT APOLOGIES FOR ABSENCE

There were no apologies received, all members were present.

C3138 DECLARATIONS OF INTEREST

a) In Items on the Agenda

There were no declarations on items on the agenda.

b) Of gifts of a value of more than £25

There were no declarations of gifts of a value of more than £25.

C3139 PUBLIC COMMENTS ON ITEMS ON THE AGENDA.

Members of the public made the following comments:

There was a high demand for beds at Roscarrack House from people in the local area. There was planning permission to extend the house unfortunately the recession had made this unviable. The 11 x 2 bedroom dwellings would allow people to own their own property, make their own decisions, have their independence and also have the option of a care package that would be provided by staff from the care home. Members of the Council had visited the site and saw that there was nothing there except the disused pipeline. The single storey dwellings would not be visible from the road. A part of the double storey dwelling may be visible from the road in the winter when the leaves had fallen off of the surrounding trees. The surrounding hedging would be increased and improved. The dwellings would be retained for specialist housing. There would be an elbow put in the wall at the end of the drive to increase visibility for motorists entering and exiting the area. There would be a restriction in the form of a planning condition or a S106 agreement to ensure that occupants were sixty or over. There would be no families living in the dwellings. The courtyard style care housing provided a much needed facility for the community allowing care to be provided without the clinical feel of care homes. For couples with mixed capabilities there would be care for the less able and support for the carer. Property owners would not be able to will the dwellings.

A resident of Budock supported the application and asked members to consider the application on its merits.

It was proposed by Cllr Hennell, seconded by Cllr Hart and:

C3139.2 RESOLVED that the planning application for Roscarrack House be brought forward to the next item.

On a vote being taken the matter was approved unanimously.

C3140 PA11/05449 - Mr & Mrs D Edwards, Roscarrack House, Bickland Water Road, Falmouth - Construction of 11 x 2 bedroom and 1 x 3 bedroom dwellings

It was proposed by Cllr, seconded by Cllr and:

C3140.2 RESOLVED that Budock Parish Council support this application. The request that a planning condition or S106 agreement state that the entry age should be 65 and over.

C3142 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL WARD MEMBER

Cllr Hatton reported that:

- Free Solar Panels Too Good To Be True warning from trading standards of people who are taking advantage – he provided the Clerk with a press release prepared by Cornwall Council to be displayed on the notice board
- Cornwall Councillors highways budgets will terminate in March 2013. The full allocation was £24000. The schemes to be completed must be submitted by December 2011 to allow time for processing. He had £16000 remaining and asked members for their thoughts on schemes at the September meeting.
- There was a meeting on the 8th August with Charlotte Chadwick the Community Network Manager. She was keen to promote localism and the cluster idea of parishes.
- There was some friction on the Falmouth side of the Maenporth boundary. The boatyard had been split and sold and there were new accesses being formed.

 Cornwall Council were reassessing where cuts could be made after public support for the bus service. The bus companies and travel watch were concerned with the lack of rural public transport.

Councillor Hatton left the meeting at 8.19pm.
