



**DRAFT MINUTES OF THE 836TH MEETING OF BUDOCK PARISH COUNCIL,
HELD AT TREVERVA VILLAGE HALL, ON MONDAY 25TH OCTOBER 2010**

C3015 TO ACCEPT APOLOGIES FOR ABSENCE

Apologies were received from Cllr Cotton.

C3016 DECLARATIONS OF INTEREST

a) In Items on the Agenda

There were no such declarations.

b) Of gifts of a value of more than £25

There were no declarations of gifts of a value of more than £25.

C3017 TO RECEIVE A REPORT FROM THE POLICE

The Clerk spoke to the report forwarded by the police. The police apologised for being unable to attend and there being no report forwarded for the September meeting. With regard to the speed gun statistics, PC Mark Hopkins carried out the most recent set of checks. He collated a list of motorists in the Treverva area who were found to be over the 30 limit and consequently had warning letters produced and forwarded to the offenders. PC Huddlestone had been unable to find the exact figures.

There are a few changes afoot, PCSO Ben Gardiner, had joined the team and will assume responsibility for Budock, Mawnan and Constantine, while PCSO Huddlestone would retain Mabe, Stithians and Ponsanooth although they would both be working together across the six parishes. It also seemed likely that PC Dave Cook would be making a return as Beat Manager in November.

PCSO Huddlestone referred the Council to the Neighbourhood Policing links for crime statistics

Budock had one crime recorded last month, being a Burglary at the Kergilliack SWW plant. Enquiries were continuing.

Cllr Fairbank asked the Clerk to again ask for details of the usage of the speed gun in the Budock Parish to include the dates and areas that it was used. Members asked that the police are requested to complete periodic speed testing in the Parish.

C3018 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL WARD MEMBER

Cllr Hatton reported that:

- Footpaths – the re-structuring of Cornwall Council was ongoing and it had not yet been decided which department would be responsible for footpaths.
- The highways grant is only available for capital projects.

- He had toured the Parish with Mr Biddick from the highways department. The parking issues on Vicarage Hill were discussed. There was not an easy solution as many measures would create parking issues in other areas. Mr Biddick was looking at possible schemes that would be suitable for the area.
- Speed Visor – Mr Biddick was re-visiting the data collected for a speed visor in Budock.
- Salt Bins – in 2011 all highways owned salt bins would be removed unless the Town and Parish Council's took over responsibility for them. Cllr Hatton said that he would purchase salt bins and fill them with salt for the Parish of Budock through his highways grant, he would then transfer the bins to the Parish Council. It was suggested that bins be placed by Treverva Village Hall, Budock Store, Budock Village Hall and School Hill. Cllr Hatton would confirm the positioning of the bins with highways. He said that there was training events planned on the 8th and 22nd November 2010 at Scorrier.

Further to discussion it was proposed by Cllr Fairbank, seconded by Cllr Hennel and:

RESOLVED that the Parish Council accept the four salt bins offered by Cllr Hatton.

It was also agreed that Cllr McCabe or Fairbank would attend the training course in Scorrier.

- Rosemerryn Farm – there had been complaints regarding overhanging trees. He had visited the site with highways. It was noted that single decked buses could get through ok. The road was not designed to accommodate large high sided lorries. There was nothing that highways could do and suggested a having a word with the land owner as the trees were their responsibility.
- The times of refuse collection would be changing due to the closure on United Mines. All waste for collection needed to be put out by 7am. The recycling collections would not alter.
- Cllr spoke to a list of facilities in the Parrish. The junior church needed to be added. The list formed the basis for village sustainability.
- Cornwall Council had taken pre-emptive steps to identify savings within the budgets. It was proposed that 90% of the savings would be made internally. Cornwall Council is the second largest unitary authority in the country. They were looking at the large number of assets that they owned.

C3020 TO CONFIRM MINUTES OF THE LAST MEETING

a) Meeting of Budock Parish Council, 27th September 2010

It was proposed by Cllr Hennell, seconded by Cllr Fairbank and

RESOLVED that the Minutes of the Council Meeting held on 27th September 2010 be approved as a true record and duly signed.

C3021 TO REPORT MATTERS ARISING FROM THE MINUTES NOT ON THE AGENDA

The Clerk said that she had spoken to Coastline Housing regarding Merry Mitt Meadow. There was little that Coastline would be able to do regarding the parking issues as they had not received any complaints from their residents. They were going to chase the repairs required to the kerb stones.

Cllr Bastin said that he had met with Mrs Jose from Cornwall Council to discuss dark lane. She seemed committed to resolving the issues with the footpath. There could be issues with funding due to budgetary constraints.

C3022 AGENDA ITEMS

a) To consider the grant application received from Budock Garden Show

Cllr Bastin spoke to the financial report received from Budock Garden Show.

It was proposed by Cllr Fairbank, seconded by Cllr McCabe and

RESOLVED to donate £25 to Budock Garden Show.

b) To consider the purchase of a poppy wreath for Remembrance Day

Cllr Bastin said that he attends the Remembrance Service held in Budock Village Hall and in previous years had laid a wreath.

It was proposed by Cllr Hennell, seconded by Cllr Fairbank and

RESOLVED that a poppy wreath be purchased for £16.50.

c) To receive the response from BT regarding the telephone kiosk in Treverva and to discuss the future of the kiosk

Cllr Hennell said that most villagers in Treverva would like the kiosk to remain in place. The villagers would want all telephony equipment removed. There were residents in the village who were prepared to maintain the kiosk. It was suggested that school children could shelter in the kiosk during inclement weather whilst waiting for the bus. It was noted that the Council would be responsible to insuring the telephone kiosk.

It was proposed by Cllr Hennell, seconded by Cllr Fairbank and

RESOLVED that the telephone kiosk in Treverva be adopted by the Council and that the residents of Treverva would maintain it.

C3023 CORRESPONDENCE

The Clerk spoke to the list of correspondence circulated to members.

C3024 PLANNING APPLICATIONS

It was proposed by Cllr McCabe, seconded by Cllr Hennell and

RESOLVED that there are no objections to this planning application.

- ii. **PA10/06087 – Mr & Mrs Begg, Lynwood, Budock Water – Conversion of garage and roof space into living accommodation and raising roof of the dwelling**

It was proposed by Cllr Fairbank, seconded by Cllr Gibson and

RESOLVED that there are no objections to this planning application.

- iii. **PA10/04399 – Mr A Capps, Plot 15, Furgo Seacore Ltd, Bickland Industrial Estate, Falmouth – Erection of a storage building alterations to existing building and construction of hard standing**

It was proposed by Cllr Gibson, seconded by Cllr McCabe and

RESOLVED that there are no objections to this planning application.

- iv. **PA10/03885 – Mr & Mrs Julian, Roscarrack Farm, Roscarrack Road, Budock Water – Listed Building Consent for alterations and extension of farmhouse and conversion and extension of disused outbuilding to form 2 holiday lets**

It was proposed by Cllr Bastin, seconded by Cllr Gibson and

RESOLVED that there are no objections to this planning application.

- v. **PA10/05733 – Mr A Smith, Craignish, Maenporth Estate, Maenporth – Extensions and alterations to the dwelling (amended design to PA08/01849/F)**

It was proposed by Cllr Bastin, seconded by Cllr Fairbank and

RESOLVED that there are no objections to this planning application.

C3025 REPORTS FROM COMMITTEES AND REPRESENTATIVES

- i. **Footpaths & Rights of Way**

Cllr Bastin asked members if they knew anything about a modification order for footpath 14. Cllr Mrs Perham said that the land owner had unsuccessfully applied to divert the footpath along the edge of the boundary.

Cllr Fairbank said that he had received a complaint that footpath 7 was overgrown. The Clerk had reported this issue to Cornwall Council.

- ii. **Budock Village Hall**

Cllr Gibson said that there had been a meeting to discuss the arrangements for Feast Night and some entertainment to be held in February or March 2011.

iii. Treverva Village Hall

Cllr Hennell reported that the AGM had been held last week. The same committee had been re-elected. The new carpet was due to be fitted in November. The 100 club had about £700 in their current bank account. In total the 100 club had about £4000 out of which they had to donate prizes.

iv. Playing Field

Cllr McCabe reported that the AGM had been held last week. The same committee had been re-elected.

v. Over 60's Club

Mrs Clark said that the AGM was held last week. The same committee were re-elected. There were currently about 40 members.

Cllr Hatton left the meeting at this point at 8.40pm.

C3026 FINANCE AND PAYMENT OF ACCOUNTS

a) Approval & Payment of Accounts

It was proposed by Cllr Hennell, seconded by Cllr Fairbank and

RESOLVED that accounts totalling **£423.50** be approved for payment and duly signed.

C3027 TO CO OPT MEMBERS OF THE PUBLIC TO FILL THREE CASUAL VACANCIES

Mr Hart said that he had lived in the Falmouth area for 59 years. He had various professional roles and had lived in various parts of the country. He had previously held a seat on Budock Parish Council but had to resign.

Mrs Clark said that she had moved to Budock Water in 1973. She worked in Budock Hospital. Currently she runs the Over 60's Club and is on the Children's Hospice South West Committee.

Further to discussion it was proposed by Cllr Hennell, seconded by Cllr Gibson and

RESOLVED that Mr Hart and Mrs Clark be co-opted onto the Council.
