



**MINUTES OF THE 860<sup>TH</sup> MEETING OF BUDOOCK PARISH COUNCIL,  
HELD AT BUDOOCK VILLAGE HALL, ON MONDAY 25<sup>TH</sup> MARCH 2013**

**PRESENT:** Cllrs Bastin, Fairbank, Mrs Clark, Gibson, Hart, Hennell, McCabe and Mrs Perham.

**IN ATTENDANCE:** Ms S Willsher, Clerk; Cllr N Hatton (until point mentioned);

The Chairman explained the safety procedures.

**C.3475 TO ACCEPT APOLOGIES FOR ABSENCE**

Apologies were received from Cllr Cotton who had also resigned from the Council.

**C.3476 MEMBERS TO DECLARE ANY DISCLOSABLE PECUNIARY AND  
NON REGISTERABLE INTERESTS AND ANY GIFTS OR  
HOSPITALITY OVER £25**

Cllr Hennell declared a code of conduct interest in the planning application for the field entrance adjoining Tresemper.

**C.3477 TO APPROVE REQUESTS FOR DISPENSATIONS FROM MEMBERS**

There were no requests for dispensations from members.

**C.3478 TO RECEIVE A REPORT FROM THE POLICE**

There was no report from the police.

**C.3479 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL WARD  
MEMBER**

Cllr Hatton reported that:

- That a temporary Radarclass speed survey would be completed at Little Lamanva. Cllr Hennell said that the police had been in the area with the mobile speed gun.
- There was a Community Grant Scheme for community owned and managed buildings.
- The Council tax had been frozen for the third year.
- Cornwall Council were considering discontinuing the Community Grant scheme and also Community Networks.
- The Local Plan was out for consultation – he felt that the housing numbers needed to be reviewed periodically. Cllr Bastin felt that there were anomalies between the towns and the surrounding parishes regarding levels of housing need.
- In response to a question he said that he had not seen the results of the street light trial.
- In response to a question he confirmed the types of projects that the community grant scheme, if it continued, could be used for.

Cllr Hatton left the meeting at 8.02pm.

**C.3480 PUBLIC COMMENT ON ITEMS ON THE AGENDA**

There were no comments from the public.

**C.3481 TO RECEIVE AND APPROVE THE MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD ON THE 28<sup>TH</sup> FEBRUARY 2013 AND THE CHAIRMAN TO SIGN THEM**

Cllr McCabe was present at the meeting

Minute C.3464 – should be 'Govier'

It was proposed by Cllr Mrs Clark and seconded by Cllr Hart and:

- C.3481.2**                    **RESOLVED** that the Minutes of the Meeting held on 28<sup>th</sup> February 2013 be approved as a true record with the above amendments and duly signed by the Chairman.

On a vote being taken the matter was approved unanimously.

**C.3482 TO REPORT MATTERS ARISING FROM THE MINUTES NOT ON THE AGENDA (FOR INFORMATION ONLY)**

The salt bin at the end of School Lane was filled with rotting garden waste and water. Members asked that there be an agenda item on the next meeting to discuss replacing the salt bin.

Cllr Bastin had met with Katie Jose from Cornwall Council to discuss 'Dark Lane'. She was checking whether the lane was still in the ownership of the farm. Budock Parish Council could make an application for the land to be classed as 'common land' providing they were willing to take full responsibility including future maintenance. There was the option to close the path; Cornwall Council would have to apply every six months to keep the path closed and would be more likely to complete the remedial works required. Katie should forward a report to the Clerk prior to the April meeting of this Council.

Cllr Fairbank asked the Clerk to check whether Roscarrack House had planning permission to remove trees in a TPO area.

The Clerk reported that the planning permission granted to Trehane was for non material planning consideration and therefore it did not need to go out for consultation.

The Council had been served notice on the office and had to vacate by the end of May 2013. Mawnan Parish Council were looking at creating an office in the Memorial Hall. Budock Village Hall had been approached and asked whether they would consider allowing the Council to use the Committee Room as an office. The Clerk would look into the viability and costs and report to the next meeting.

**C.3483 TO CONFIRM THE OWNERSHIP AND INSURABLE INTERESTS OF BUDOCK VILLAGE HALL, TREVERVA VILLAGE HALL AND BUDOCK PLAYING FIELD**

The Clerk reported that she had read the documents available and believed that the Parish Council were Custodian Trustees of both Budock Village Hall and Treverva Village Hall. She had not found the paperwork on the playing field. Members disagreed and felt that both village halls were owned by the Council. The Clerk recommended that the paperwork was sent to a specialist solicitor for confirmation. Further to an in depth debate it was agreed that no further action was taken.

**C.3484 TO RECEIVE THE COMMUNITY INFRASTRUCTURE LEVY PRELIMINARY CHARGING SCHEDULE CONSULTATION AND AGREE A RESPONSE**

It was proposed by Cllr Hennell and seconded by Cllr Fairbank and:

**C.3484.2 RESOLVED** that Budock Parish Council agree in principle to the Community Infrastructure Levy Preliminary Charging Schedule.

On a vote being taken on the matter there were 7 votes FOR and 0 votes AGAINST.

**C.3485 TO RECEIVE THE CORNWALL LOCAL PLAN 2010-2030 STRATEGIC POLICIES PRE-SUBMISSION DOCUMENT MARCH 2013 AND CONSIDRE A RESPONSE**

It was agreed to defer this item until the next meeting.

**C.3486 TO CONSIDER THE GRANT APPLICATION FROM TREVERVA AND LAMANVA FRIENDSHIP CLUB**

It was proposed by Cllr Gibson and seconded by Cllr Hart and:

**C.3486.2 RESOLVED** that there is no donation to Treverva and Lamanva Friendship Club as they were due to receive funds from the Community Trust.

On a vote being taken the matter was approved unanimously.

**C.3487 TO RECEIVE THE GRANT APPLICATION FROM TREVERVA VILLAGE HALL**

It was proposed by Cllr McCabe and seconded by Cllr Hart and:

**C.3487.2 RESOLVED** to donate £123.45 to Treverva Village Hall.

On a vote being taken the matter was approved unanimously.
