



**MINUTES OF THE 834TH MEETING OF BUDOOCK PARISH COUNCIL,
HELD AT BUDOOCK VILLAGE HALL, ON MONDAY 26TH JULY, 2010**

C3001 TO ACCEPT APOLOGIES FOR ABSENCE

There were no apologies received.

C3002 DECLARATIONS OF INTEREST

C3003 TO RECEIVE A REPORT FROM THE POLICE

There was no such report.

C3004 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL WARD MEMBER

Cllr Hatton reported that:

- The government have frozen council tax for principal authorities. Cornwall Council are awaiting further guidance on the impact for Town and Parish Council precepts, the police and fire authorities.
- Mr Biddick from the highways department of Cornwall Council will look at the damaged curb stones in Merrymit Meadow
- Community Networks – the effectiveness of the community networks vary depending on the area.

C3005 PUBLIC COMMENTS ON ITEMS ON THE AGENDA

A member of the public expressed their concern regarding the planning application relating to Lynwood, Budoock Water. They raised the following concerns:

- The size of the proposed extension
- Loss of sunlight to the neighbouring property
- Increased noise due to location of proposed front door
- Loss of privacy due to dormer windows and balcony
- Out of keeping with other properties in the area
- Overdevelopment of the site

C3006 TO CONFIRM MINUTES OF THE LAST MEETING

It was noted that the meeting was held in Treverva Village Hall.

Cllr Bastin reported that there were a lot of brambles on the footpath between Chapel and Menhay and he had removed them.

C3007 TO REPORT MATTERS ARISING FROM THE MINUTES NOT ON THE AGENDA

The Clerk reported that Coastline Housing have put the work required at Merrymit Meadow and School Lane out for pricing. They will then place a works order with their contractor.

The Clerk has chased Cornwall Council regarding the removal of the rusty pole at the end of School Lane. Cllr Fairbank said that the pole has been removed.

Cllr Bastin said that a new notice board had been purchased due to the construction of the meeting room at the Church and the poor condition of the original notice board. The notice board will be erected shortly.

Cllr Fairbank asked the Clerk to contact the police and discuss the use of speed guns in the village.

Cllr Mrs Perham said that she has reported to Cornwall Council that the steps leading to the distributor road need clearing.
