



**MINUTES OF THE 840th MEETING OF BUDOOCK PARISH COUNCIL,  
HELD AT BUDOOCK VILLAGE HALL, ON MONDAY 28<sup>th</sup> MARCH 2011**

**C3069 TO ACCEPT APOLOGIES FOR ABSENCE**

Apologies were received from Cllrs Fairbank, Hart, McCabe and Hatton.

Cllr Bastin welcomed the Clerk back from her illness.

**C3070 DECLARATIONS OF INTEREST**

**a) In Items on the Agenda**

There were no interests declared.

**b) Of gifts of a value of more than £25**

There were no declarations of gifts of a value of more than £25.

**C3071 TO RECEIVE A REPORT FROM THE POLICE**

PCSO Gardner spoke to the report. He said that since the last meeting there had been two crimes reported in the Parish. There was a criminal damage which occurred at a domestic incident and a coat was taken from a restaurant. There were no reports of antisocial behaviour. There had been speed watch event on Bickland Water Road which involved primary school children, and also patrol units from Falmouth had been out with the speed enforcement device. He then asked if the Council would be prepared to give written permission for the police to stand outside of Treverva Village Hall whilst conducting speed watch operations. Cllr Gibson suggested that the police conduct speed watch operations where School Lane meets the main road. PCSO Gardner said that the new Sergeant had reviewed the designated speed watch areas.

PCSO Gardner left the meeting at 7.45pm.

**C3075 TO REPORT MATTERS ARISING FROM THE MINUTES NOT ON THE AGENDA**

Cllr Bastin reported that the LMP paperwork from Cornwall Council had still not been received. He said that the Council were running out of time to send out the tenders and appoint a contractor in time for the first cuts which were due in April/May. Further to discussion it was:

Cllr Mrs Perham said that she had been unable to identify the unsafe stile in the Nangitha/Kergilliack area. It was agreed that further information be sought from the complainant.

**C3076 AGENDA ITEMS**

**a) To receive and approve the quote for cleaning the two bus shelters in the parish**

It was proposed by Cllr Hennell, seconded by Cllr Mrs Perham and

**b) To receive and approve the quote for maintenance to the pump garden**

It was proposed by Cllr Gibson, seconded by Cllr Mrs Clark and

**C3076.3**                    **RESOLVED** that the quote for the maintenance of the pump garden with the exception of the notice board for a total cost of £92.98 be accepted. The seat would be stained dark brown and the pump painted matt black.

**c) To receive the response from BT regarding the telephone kiosk in Treverva and to discuss the future of the kiosk**

Cllr Hennell spoke to the response received from BT.

It was proposed by Cllr Hennell, seconded by Cllr Bastin and

**C3076.4**                    **RESOLVED** that the telephone kiosk in Treverva be adopted by this Council once the telephone and all electrical connections had been removed.

**d) To consider a suitable memorial for the late Mr Tony Kellow, 'a football star from Budock'**

Cllr Bastin said that he had asked for this to be an agenda item to allow members to brain storm ideas. It was noted that Mr Kellow was a well known footballer especially in the Exeter area, his funeral was shown on television and one year he received the prestigious 'golden boot'. It was suggested that a plaque could be erected either in the memorial garden, on the playing field or on the bench in the memorial garden. Further to discussion it was agreed to defer this item to the next meeting of the Council and that Mr Kellow's family and the Exeter Supporters Club be contacted and asked for their views and ideas. Members asked the Clerk to research costings on plaques and benches and also look into designs available.
