## MINUTES OF THE 908<sup>TH</sup> MEETING OF BUDOCK PARISH COUNCIL HELD AT BUDOCK VILLAGE HALL ON MONDAY 26<sup>TH</sup> FEBRUARY 2018

The Chairman explained the Safety Procedures prior to Public Participation.

Mr Andrew Dunstan of Menehay Touring Park gave the meeting a brief presentation on his future plans to extend the Touring Park; and answered questions from the Councillors.

# 17-202 TO RECEIVE A PRESENTATION FROM TREWIN DESIGN ARCHITECTS LTD REGARDING THE DEVELOPMENT OF LAND OFF KERGILLIACK ROAD

Mark James from Trewin Design Architects gave a presentation on the outline plans that will shortly be submitted for a development of 37 dwellings on land off Kergilliack Road (adjoining the Union Park development). This was followed by a question and answer session with particular concern being expressed regarding the proposed access to the site from Kergilliack Road, and the loss of trees and hedges.

- Cllr Heritage is meeting with Home Choice regarding the affordable homes target for the parish / Community Network Area.

# 17-205 TO CONSIDER AND APPROVE AN APPLICATION FOR A S.133 GRANT IN RESPECT OF THE REPLACEMENT OF THE WALL HEATERS AT TREVERVA VILLAGE HALL

It was proposed by Cllr Geraty and seconded by Cllr Heritage and:-

**RESOLVED** that payment is approved in respect of a S.133 grant for the cost of replacement wall heaters at Treverva Village Hall.

On a vote being taken this was unanimously agreed with 2 abstentions.

#### 17-206 TO FURTHER DISCUSS SPEED VISOR OPTIONS

After a short discussion it was agreed that the Community Speed Watch team will look into all the information received on various options and report back at the next Council meeting.

## 17-207 TO RECEIVE A REPORT ON THE YEARLY ASSET CHECK CARRIED OUT THIS MONTH

This has been carried out. The Treverva Defibrillator and all the salt bins in the parish need to be added. It will be an agenda item next month to approve the updated asset list.

## 17-208 TO CONSIDER AND AGREE A PROCEDURE FOR ENSURING OUR SALT BINS ARE KEPT TOPPED UP AS REQUIRED

After a lengthy discussion it was proposed by Cllr Fairbank and seconded by Cllr Hart and:-

**RESOLVED** that Cormac (Highways) are requested to keep the salt bins topped up for the rest of this winter.

This was agreed with one abstention.

Agenda items 16 and 17 brought forward to this point as Divisional Councillor Bastin needed to leave the meeting early.

#### 17-209 TO DISCUSS THE PROPOSED REALIGNMENT OF OUR ELECTORAL DIVISIONAL BOUNDARY

Cllr Bastin informed the meeting that Cornwall Council have proposed to merge the whole of Budock Parish with part of Falmouth in the realignment of Divisional Boundaries. The proposed name is Falmouth – Trescobeas. Cllr Bastin has requested that the name of Budock is retained. Once these Divisional Boundaries are finally agreed then the Boundary Commission will decide on any changes to be made to parish boundaries.

A heated discussion took place on this with the main points being the unsuitability of merging an essentially rural parish with an urban area. This merger would also mean the divisional area would be partly in 2 separate parliamentary constituencies.

It was proposed by Cllr Hennell and seconded by Cllr Geraty and:-

**RESOLVED** that all necessary measures are taken to inform our electorate of this proposal.

On a vote being taken this was agreed with one abstention.

#### 17-210 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL DIVISIONAL MEMBER

Cllr Bastin reported the following:-

- Midas have informed him they intend to divert Footpath 26 around the edge of Lower Wayfield while building works are taking place. The Clerk said she has received no official notification of this.
- A reminder was given of the next CNA meeting that is taking place at Mawnan Smith Bowling Club on Tuesday 6th March.

Cllr Bastin left the meeting at 8.29pm.

After discussion and considering the amendments to the original plan it was proposed by Cllr Fairbank and seconded by Cllr Hart and:-

**RESOLVED** that the following comment is submitted:- Budock Parish Council stands by its original comment on this application. It objects as this will still effectively result in a new dwelling in the countryside, contrary to the NPPF. Also there is no further mention of the issue that approval of this application would appear to formalise what is now a farm track becoming a permanent recognised road to the new dwelling.

On a vote being taken this was agreed with one abstention.

# ii) PA18/01270 – Removal of condition 6 in relation to decision notice 2/05/84/00940/0: Clubhouse restriction to occupants of holiday village – Chalet Park Office, Pendra Loweth, Maen Valley – Mr J Hick

After discussion it was proposed by Cllr Fairbank and seconded by Cllr Geraty and:

**RESOLVED** that the following comment is submitted:- Budock Parish Council object to this application. It can see no reason to lift condition 6 which restricts the use of the facilities to the residents of Pendra Loweth. If this condition is lifted the result is that the clubhouse would effectively become a fully-fledged Public House.

On a vote being taken this was agreed with one abstention.

iii) PA18/01018 – Construction of a new extension to Unit 2 to house a new storage freezer with loading bay, rooms to house further storage/production, a new access to the existing first floor offices, improved HGV turning and handling, and remodelling the rear car park – Unit 2, Bickland Industrial Park – Mr Brian Lamerton-Reece, Taylor Rose Construction

After discussion it was proposed by Cllr Fairbank and seconded by Cllr Hart and:

**RESOLVED** that the following comment is submitted:- *Budock Parish Council supports this application.* 

On a vote being taken this was unanimously agreed.

#### 17-217 TO NOTE PLANNING ENFORCEMENT COMPLAINTS RECEIVED BY CORNWALL COUNCIL

#### 17-218 REPORTS FROM COMMITTEES AND REPRESENTATIVES

- iii. **Treverva Village Hall** Defibrillator training has taken place and was found extremely useful. Another training session is planned.
- iv. Playing Field –. The Playing Field has received a grant from Tesco Bags for Life of £2,000 and plan to install an outdoor table tennis table in the field. Cllr Geraty agreed to become the Parish Council representative on the Playing Field Committee. The Clerk will request the last annual accounts from the Playing Field Committee.
