#### 24-91 REPORTS FROM COMMITTEES AND REPRESENTATIVES

**Footpaths and rights of way** – Nothing to report.

**Tree Warden** - Nothing to report.

**Budock Village Hall** - The New Secretary has started, and the asbestos survey has been put on hold due to the potential damage to walls. The next Budock Village Hall meeting is 12 September.

**Treverva Village Hall** – Treverva Hall's meeting scheduled for July 15th was cancelled due to too many Committee Members being absent the AGM will be in October.

**Playing Field** –. The Playing Field has continued its renovation with new picnic benches and a couple of volunteers (Phil and Sue Kellow) as well as Matt and Austin helping to clear the remaining branches from the emergency tree surgery last winter.

The committee are still in negotiations with the contractors for them to repair the faulty paintwork and have not yet paid any of the total costs.

The committee was granted £500 by Falmouth Fire brigade who raise money through their fireworks display each year. (Thanks to Darren for organising this). Matt, Amos, Anna, and Fletcher went to receive the cheque last month.

We are possibly looking at an event in September to officially open the renovated park, but we have no details as yet.

A quote to repair and paint the finger signs had been received and agreed this has now been completed and all the finger posts in the parish have been repaired and painted.

The missing arm on the finger post at the top of the village turning into the road leading to the church will be reported to highways.

**24-96 TO AGREE THE COSTS OF A REPLACEMENT NOTICE BOARD FOR BUDOCK VILLAGE UNDER HEALTH AND SAFETY REASONS**

It was discussed and agree that the main notice board has a broken hinge. Cllr Palmer has repaired it temporarily, but the board will need replacing. It has been agreed that this should be delegated to the clerk and chairman to agree which board should be ordered, and the costs needs to be under £2,000 if over this budget it will have to be returned to full council for discussion.

It was proposed by Cllr Hennell and seconded by Cllr Spear and: -

**RESOLVED** that the replacement notice board in Budock be ordered in agreement with the Chairman and clerk to the value of £2,000.

On a vote being taken this was unanimously agreed

**24-97 TO UPDATE ON THE SIGHTING OF A TRAFFIC MIRROR IN TREVERVA**

After discussion and seeking legal confirmation from Highways about placing such mirrors on the highway it was suggested by Highways that the neighbouring properties to the lane be contracted by the resident to trim the hedges back to allow greater vision. Highways also said that such mirrors are a last resort as sometimes the glare from them is also a danger to motorists. It was agreed that the clerk would continue to contact Highways to try to request they come to site to conduct a safety report.

A site meeting with Highways has been agreed for the end of August.

The subject of the finger posts in the parish.

Tree work on roadside and road surface on No man's land both have been reported to Cornwall Council.

It was explained that upon legal advice the Council could not save money for any cause that is not yet apparent. The clerk explained that a certain amount should be held in reserve to maintain expected expenditure especially as the precept percentage increase is liable to be capped by central government each year and this may result in a position where the Council could not even cover that year's inflation.
