Treverva Village Hall –. AGM - Finance. Running at an annual loss of £600. Healthy balance of £17k due to COVID payments but not sustainable in long run. Committee re-elected as per last year. Mulled Wine night 12th December .

Playing Field –. Nothing to report other than notice of our AGM which will be on 7th November at the Village Hall 8pm. Lights switch on 29th November.

Highways have confirmed that the matter has been passed to the department for investigation and they will inform us what action will be taken when they have a report ready. This will be monitored and only returned to council if expenditure is required.

After a site visit had taken place at Treverva with Cornwall Council Highways it has now been taken to the Treverva Village Hall committee. Treverva Village Hall have agreed to install a mirror on the building they have now applied to Budock Parish Council for a grant to purchase the mirror.

RESOLVED that a grant of up to £50, for the purchase of the mirror to be installed on the Hall, be given to Treverva Village Hall.

The surgery held at Budock on the 24th October 2024

There was an improved level of involvement by parishioners whose main points were.

- Street light failure at the junction of Trevoney
- Question regarding Greenspot fire and what is the current situation as the smell is continuing through the village.
- If it is possible to have priority road signage between Gypsy Lane and Bickland Hill.
- Would it be possible for the Budock Parish Council to give a grant of £50 towards Christmas lights as the trees have been sponsored by local business.
- To hold Budock Parish Council surgeries every quarter on a Thursday morning for Budock.

The surgery held at Treverva on the 26th October 2024

Two residents attended the surgery. The main points were.

- Viva Treverva have not maintained hedgerow since present owner bought it.
- The 'Flower Girls' allotment at Viva Treverva has been confirmed as a commercial business.
- Hillhead Road nightmare of closures. Missed opportunity to widen road. People giving up on going into Falmouth/Penryn.
- Comments about the chapel. Nothing happening and exterior visibly decaying.
- Questions on enforcement of Viva Treverva issue referred to 24-127 of our minutes.
