As it stands there is the hope that building regs will be applied and a quantity surveyor employed by around April 2025. A fire assessment is being organised by Michael. Darren Jan-Janin was unanimously voted in as the new chair, Matt was unanimously voted in as secretary and Will Leggett was unanimously voted in as treasurer. The Christmas lights switch-on is booked for Friday 29<sup>th</sup> November, 6pm.
