Tree will become exposed if T2 and T3 are removed due to basal cavities and major dead wood; (on a separate 5-day notice). T4 Beech – Reduce height to upper crown, from 16 to 13m, plus reduce eastern crown, from 8 to 6m, cutting to a suitable growing point. Heavily asymmetric crown, weighted towards Argal Lodge Location Argal Manor Kergilliack Falmouth Cornwall TR11 5PD Grid Ref 176750 / 32804 (Case Officer - Abbie Franklin)
